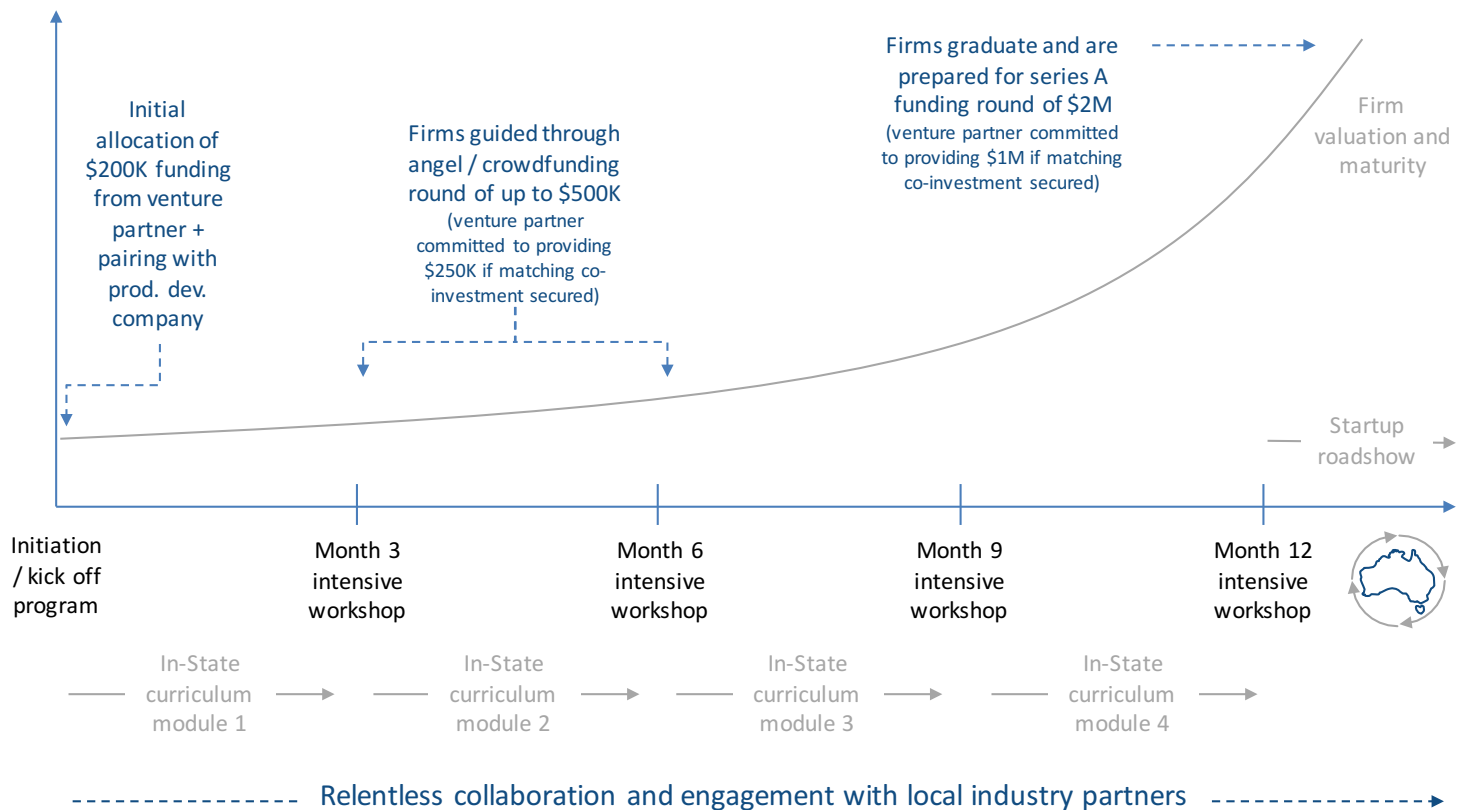
- ✓ Create a dynamic medical technology (MedTech) startup ecosystem in Australia

Vision	The Actuator will set a new global standard for MedTech* acceleration and commercialisation, deploying a dynamic, multi-faceted and integrated program that supports innovators and entrepreneurs to rapidly translate and commercialise new ideas into solutions that change the face of healthcare
Approach	Capitalising on Australia's existing research, service and product development strengths, the Actuator will build, connect and optimise Australia's MedTech performance by priming, augmenting and developing our state-based innovation ecosystems through a national-focused strategy
Program	Fed by priming programs deployed at the state level, the Actuator's flagship acceleration initiative will consist of a 12-month intensive venture and technology development program – taking seed ventures to Series A investment and leading into clinical trial, advanced manufacturing and at-scale technology deployment

INVESTMENT STRATEGY

The Fund will invest in a diversified portfolio of Australian MedTech startups that are preselected by The Actuator into its national accelerator program and from the broader startup ecosystem.

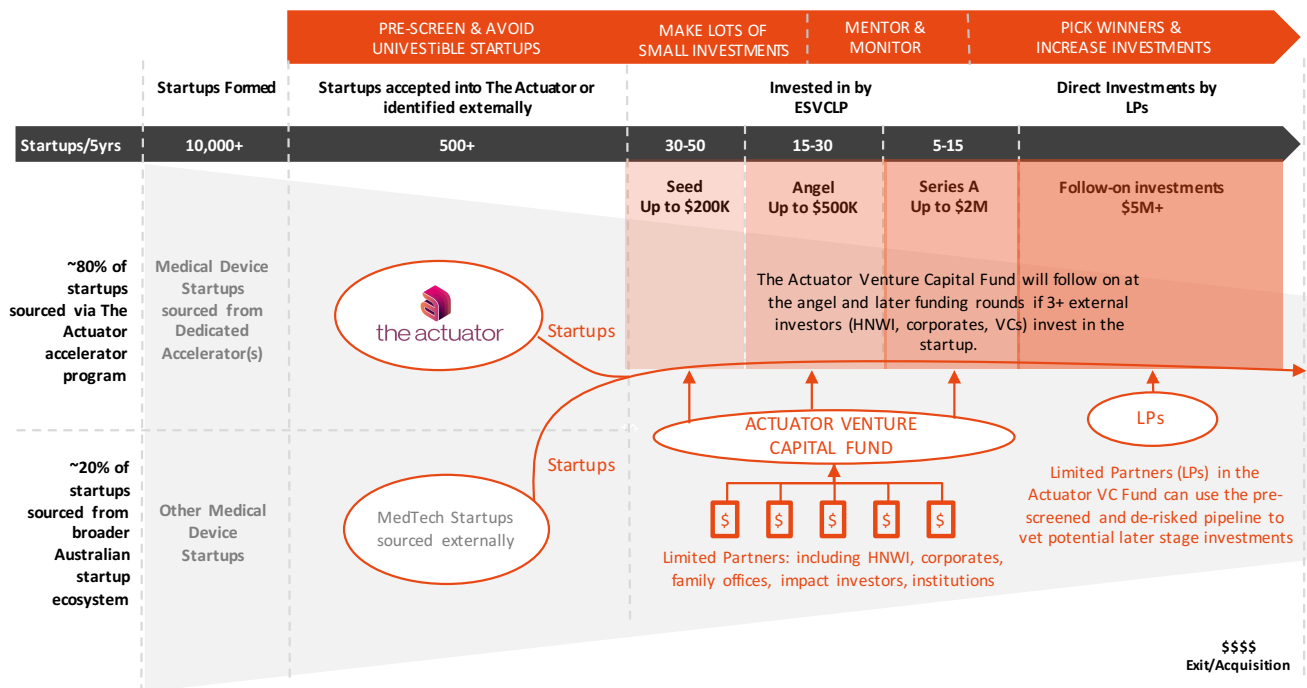
A unique feature of the Fund is that it invests at the seed stage and offers MedTech Startups follow-on funding at both the angel stage and later-stage funding rounds.

The Fund's investment objective is to target an annualised return of >20% over 7-9 years by investing in a diversified portfolio of approximately >50 high-growth potential MedTech startups accessed via the pre-screening and acceleration processes of The Actuator program.

The 4 key tenets of the Fund's investment strategy are:

1. build a diversified portfolio of seed stage investments with a pro-rata right to follow-on in subsequent funding rounds,
2. focus on scalable, high-growth potential MedTech Startups,
3. make follow-on investments at angel and later stage VC rounds into startups proving traction/market fit, and
4. target the \$50-100 million M&A/trade sale market for exits.
